Capt. Ernest Howell, son of Mr. and Mrs. J. W. Howell of Green Mountain, was injured in an airplane mishap last Wednesday ten miles iorth of Kinston, N. C. An Air Force cadet, Lt. Kenneth L. Collins, was killed in the crash.

Capt. Howell, who saw action in the Pacific Theatre of Operations during the last war, has been training young pilots for some time.

Capt. Howell is in a hospital where he was placed in a cast because of back injuries. The extent of his injuries have not been released. "Captain Ernest Howell is to be commended for his efforts to save the T-6 aircraft and student involved in the fatal accident here Wednesday. Preliminary investigation disclosed the fact that the aircraft entered a normal training spin at 8,000 feet. When a normal recovery had

not been effected at 9,000 cos, Capt. Howell attempted to get the aircraft out of the spin. It was evident that the spin could not be controlled under the conditions. Capt.




