



## JIFFY ONION BISCUITS



Combine melted butter and instant minced onion; let stand a fewr inutes. Arrange biscuits on ungreased baking sheet. Using the clour-dipped bottom of a jelly glass; make a depression in the center of each biscuit. (Biscuits will flatten and rise up around. edge of glass to make a low "rim".) Fill each depression with onion-butter mixture. Bake in a very hot oven (450 degrees F.) 8; to 10 minutes, or until biscuits are done and onion is toasted. Serve warm. Makes 10 biscuits.
