You are required to make defense to such pleading not later than the 19 day of November, 1965, and upon your failure to do so the Plaintiff will apply to the Court for the relief sought.

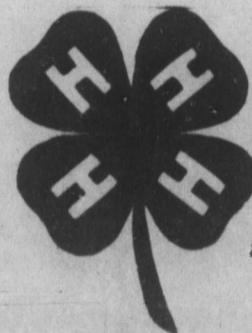
