**Final Judging In
Comm. Development
To Get Underway**

Final judging in the 1965 Western North Carolina Rural Community Development Program will get underway on Monday, November 8 and run through Thursday the 11th. At stake will be top honors in the area-wide community improvement contest, which drew entries from 115 organized areas this year.

Competing in the area judging will be 15 county winners in the Farm Division and 15 winners in the Non-Farm Division. Each community will be visited by a team of judges, who will spend one hour and 45 minutes in each area. They will hear progress reports by community leaders and will inspect community, home, farm and business improvements.

Brush Creek community will represent Yancey county in the Farm Division and will be judged on Wed. November 10 at 11:00 a. m. Newdale community will represent the county in the Non-Farm Division and will be judged on Monday, November 8 at 9:00 a. m.

Communities in the final judging are competing for the honor of being named "The most progressive" area in Western North Carolina and also a share of the \$4,500.00 in area awards offered in the program. Winners will be announced at the annual awards luncheon of the sponsoring Asheville Agricultural Development Council on December 4 in the Asheville City Auditorium. Over \$8,000.00 in local awards have already been awarded in the various county contests.

According to Morris L. McGough, Executive Vice President of the Asheville Agricultural Development Council, judges for the Farm Division will be Mrs. Sue L. Alfriend, Assistant Vice President, The Northwestern Bank & Trust Company, North Wilkesboro; Dave Williams, Technical Representative, Dow Chemical Company, Asheville; Dr. C. Walton Jones, Extension Economist, Public Policy, N. C. State University.

Judges for the Non-Farm Division will be Mrs. Ruth Sheehan, Assistant Extension Editor for Television, N. C. State University; George M. Tisdale, Public Relations Manager, Southern Bell Telephone & Telegraph Company, Asheville; Jim Cox, Area Coordinator, Travel & Tourist Service, Asheville-Buncombe Technical Institute, Asheville.

The WNC Community Development Program, now completing its 16th year, is sponsored by the Agricultural Council in cooperation with the Agricultural Workers Council in each county and local sponsors.
