# New Policies Regarding Employment for Students

WASHINGTON — The
Federal government has adcpted new policies regarding
the summer employment of
students which will be of
vital interest to all those
young people who would like
to get jobs with Federal
agencies next summer.

Before becoming eligible for these jobs, all students must take a special examination which will be given by the Civil Service Commission sometime in late January or early February.

But just as important as taking the examination itself is the requirement that those interested in summer fobs must apply to take the Civil Service exam not later than January 3, 1966.

Applications to take the exam can be obtained at any Post Office. This special application, Card Form 5000-AB, should be filled out and mailed to the U.S. Civil Service Commission, Washington, D. C., 20415. The Civil Service Commission will notify those who apply

to take the examination as to when it will be given.

Tentative plans call for the exam to be given at the following locations in North Carolina for the convenience of students: Asheville. Charlotte, Durham. Elizabeth City, Fayetteville, Gastonia. Goldsboro. Greensboro. Greenville, Hickory, New Bern, North Wikesboro, Raleigh, Rocky Mount, Salisbury, Sylva, Washington. Wilmington. and Winston-Salem.

The Civil Service Commission has sent out a special notice emphasizing that all summer jobs will be filled on the basis of merit in the future. The Commission also emphasizes that no applicant will be considered for employment who does not

take the special examination.

Bummer jobs with the government offer a tremendous opportunity for students to earn extra income during the vacation period and at the same time learn a great deal about how the Federal government operates

#### NEW TRAFFIC SAFETY LAWS

Listed below are a number of new traffic safety laws enacted by the General Assembly of North Carolina in 1965.

It will be unlawful to operate a motor vehicle, manufactured, assembled or sold after January 1, 1966, upon the highways of the State unless equipped with at least one outside mirror on the driver's side. This statute, of course, does not apply to any automobile bought by you prior to Jan. 1, 1966.

A statute was amended to require "in all areas where the speed limit is 45 m.p.h. or higher and the operator intends to turn from a direct lane of travel, a signal of intention to turn from a direct lane of travel shall be given continuously during the last 200 feet traveled before turning."

It is unlawful for a blue warning light to be operated on a motor vehicle except by a law enforcement officer who is actively engaged in the performance of his duties. So if you see a flickering blue light signal coming from a motor vehicle, there is some reasonable assurance that there is a pol-

ice officer therein performing his duties.

It is a criminal offense for any person to wilfully stand, sit, or lie upon the highway or street in such a manner as to impede the regular flow of traffic.

It is unlawful to stand on highways, except on shoulders. to solicit a ride.

It is a criminal offense to stand or loiter in the main traveled portion of a high-way or street, including shoulders and medium, but excluding sidewalks, or in any manner stopping a motor vehicle to solicit contributions, business, or employment from the driver or occupant.

Motorcycles cannot be operated more than two abreast except on ceremonial occasions supervised by law enforcement officers.

A minor between the ages of 16 and 18 cannot obtain an operator's l'cense for an actomobile unless he presents evidence of having satisfactorily completed the driver training and safety education courses offered at the public high schools.

There was passed the much publicized automobile inspection statute.

#### Time To Deposit Excise Tax

It's time to deposit Federal excise taxes, according to the Internal Revenue Service. Manufacturers and others, who are liable for more than \$100 of excise taxes for November must deposit taxes no later than December 31, 1965.

Form 537 should be used and deposits made in a Federal Reserve Bank or an authorized commercial bank.

Detailed information on this subject is available upon request from the Internal Revenue Service.
