

## Girl Scout Leaders Hold Neighborhood Meeting

Thursday morning, Sept. 8, a Neighborhood meeting of the Girl Scouts was held in the home of Mrs. Paul Laughrun. Mrs. Don Burhoe, Neighborhood Chmn. presided. Attending were: Mrs. Don Burhoe, Neighborhood Chairman; Mrs. Paul Laughrun, the hostess; Mrs. Jack Edwards and Mrs. O. W. Deyter, District Advisors of the Pisgah Council; Mrs. Pete Colletta, Mrs. James McWhirter, Mrs. Lee Hicks, Mrs. John Powers, Miss Zoe Young and Mrs. W. E. McKinney.

One highlight of the meeting was a discussion of Day Camp activities of this summer. Over 1200 girls attended day camp this year compared to 690 a year ago. Day camps were under the supervision of Girl Scout Field Advisers with record number volunteers assuming the responsibility of staff chores. Approximately 125 free camperships were offered to those who needed them.

The Neighborhood officials also discussed plans for the annual meeting of the Girl Scout Council. It was announced that Dr. P. F. Ayers, Executive Director of the Council of the Southern Mountains, Berea, Kentucky, would be the banquet speaker. Dr. Ayers, an outstanding speaker is a professor at Berea College.

Mrs. Jody Barber, Second Vice President of the Board of Directors is serving as chairman of the annual meeting to be held October 18 at the Battery Park Hotel in Asheville.

Also discussed was the Annual Girl Scout Cookie Sale. Volunteers to serve as coordinator in the various Neighborhood in the Pisgah Council are now being signed up, according to Ken McCandless, General Chairman of the event. Last year in the 16 counties served by the Pisgah Council 121,212 boxes of Girl Scout cookies found their way into Western North Carolina homes.

"The profit from the annual cookie sale assists the council in carrying out the activities during the entire year. Along with the United Fund contributions and independent drives in those counties without United Funds the cookie sale is one of the economic 'backbones' of the council," McCandless said.

Also on the agenda was consideration of ACA Campcraft Course which will be held Saturday and Sunday, September 17 and 18. The course is designed to provide training in outdoor living skills. All interested adults are given the opportunity to qualify in campcraft. Emphasis will be placed on food and cooking, fire tools, nature and conservation, trips, camping gear, and use of map and compass. According to Herbert Macemon, coordinating trainer, "With the increased growth of camping in the United States and particularly in Western North Carolina, this course, we feel, is a must for all those who seek professional training in the art of living in the outdoors." Mrs. Wilard Crowder of Micaville is coordinator for the Yancey group.

Plans were also mapped for the regular Field meeting Thursday, September 29, in Spruce Pine. Field Advisers, Neighborhood Chairman and

professional staff members will meet to redefine responsibilities of each of these groups. An evaluation of Day Camps will be included.

September 27 Buncombe, Henderson, Transylvania, Madison and Polk Counties are scheduled at the Girl Scout office in Asheville from 10:00 a. m. to 2:00 p. m. September 28 a similar meeting for Jackson, Haywood, Macon, Swain, Cherokee, Graham, and Bryson City; and, September 29 representatives from Avery, Mitchell, Yancey, McDowell and Spruce Pine will be meeting.

## Civil Service Exams Open In N.C.

In North Carolina until further notice Civil Service Examinations will be open for substitute clerks and substitute city carriers. Applications for these examinations may be made to: U. S. Board of Civil Service Examiners, P. O. D., Room 100, Main Post Office Building, Atlanta, Georgia 30304.

Application cards may be obtained at any post office.

Starting salary: First and Second Class offices \$2.64 per hour; third class offices, \$2.26 per hour.

The minimum age limit for these positions is 18. However, this age limit is waived for high school graduates. They may be appointed when they reach their 16th birthday, provided local child labor laws permit. This age limit does not apply to persons entitled to veteran preference.
