No Opposition Raised On Parkway Hearing

WASHINGTON — Not a single voice of opposition was raised here Friday during a hearing on legislation introduced by 11th District Rep. Roy A. Taylor and by two Georgia Congressmen to extend the Blue Ridge Parkway to Atlanta, Ga.

Witness after witness told members of the National Parks and Recreation Subcommittee of the House Interior Committee that the 180-mile addition to the famous scenic highway is urgently needed to meet recreational demands from bustling metropolitan centers in the Southeast.

Rep. Taylor, Chairman of the subcommittee, and Georgia Congressmen John W. Davis and Phil Landrum, co-authors, called for enactment of the legislation as quickly as possible to enable the two states to begin acquiring rights-of-way.

National parkway experts from the Department of Interior told the subcommittee that extension of the parkway is a logical development to meet national recreation demands.

Michael Frome of Alexandria, Va., noted author in the field of conservation and one of the chief spokesmen of the national conservationist movement said the project has his "whole-hearted and enthusiastic support." He called the Blue Ridge Parkway "the finest, best-planned motor highway of its kind in the world."

Witnesses from Western North Carolina included Frank Brown of Cullowhee, Chairman of the North Carolina National Park, Parkway and Forests Development Commission; Richard K. Degenhardt, Executive Vice President of the Asheville Chamber of Commerce; and Tom L. Malcnee of Candler, President of Western North Carolina Associated Communities and Rep. Taylor's District Assistant.

A report submitted to Congress in 1963 in which the extension was strongly recommended estimates its cost at \$87,536,000. Taylor stressed that construction can be funded from already-authorized annual parkway construction appropriations and would not necessitate any increase in present nationwide parkway construction spending.
