

#### Former Yancey Resident Found Dead In Fla.

A former resident of Yancey County, N. C., was found dead Monday in a parked car on Interstate 4 near Longwood, Fla.

The Florida State Patrol said Bobby Joe Ray, 30, of Sanford, had been shot in the chest. His wallet was missing. An investigation is continuing.

Ray had been working for about a month in Florida, where he lived with a sister. He was a son of Mrs. Ozain Ray of Burns-

ville, N. C. Rt. 5.

Surviving in addition to the mother are two sisters, Mrs. Cl'mas Autrey of Burnsville Rt. 5 and Mrs. Opal Woody of Sanford; five brothers, Frank of Erwin, Tenn., James of Marion, N. C., Clarence of Fullerton, Calif., and Kenneth and Billy Ray, both of Burnsville, Rt. 3.

### Bailey Announces For House

J. Yates Bailey of Bald Creek made the announcement this week of h's intention of becoming a candidate for the State House of Representatives from this district.

Baley, a former teacher, served a term in the State Senate when Yancey was in a district with Mitchell and Avery Counties. This Senatorial District is now made up of Yancey, Madison and Haywood counties.

In making the announcement Bailey said he felt that Haywood County with its population would have a Representative from that county each session of the Assembly and that Madison and Yancey counties should rotate each session.

In the last election, L'ston B. Ramsey was elected from Madison County as one Representative from the district.

Bailey also pointed out that Yancey County Democrats passed a resolution to place the county back on the pr'mary election system for the selection of candidates for the general election and that this change was not made during the last legislative session. Bailey said he is in favor of the pr'mary system.

A school teacher for many years in this and other counties, Bailey has always been active in church and civic affairs in his community and in the county. He is president of Burnsville Lions Club and has been renominated to serve as the club's president for another year.

### E.Y. FHA Chapter Wins First Place

The East Yancey Chapter of Future Farmers of America finished first among 10 entries to win the annual Blue Ridge Federation Land Judging Contest, held at Mars Hill on Thursday, March 14th. The North Buncombe FFA finished 2nd, Marshall FFA was 3rd, A. C. Revnolds was 4th, and Charles D. Owen was 5th.

The winning team consisting of Jack Hensley, Mike R ddle, Leonard Grindstaff and Byrl S'mmons will advance to the State Land Judging Contest to be held in Haywood County on April 6th. The team was coached by Herbert D. Allen, Vo-Ag Instructor at East Yancey Hgh School.

This contest which is promoted by the Soil Conservation Service and sponsored by the Carolina Power and Light Company, emphasizes a thorough knowledge of land characteristics and recommended practices to assure continued high crop production from this natural resource.

Purpose of the scholarship is to encourage a boy or g rl from the area to enter the professional field of horticulture and to provide financial assistance to them in attend ng college.

The grant will be \$500.00 for the 1968-69 school year, with the opportunity to renew for a maximum of four years or a total \$2,000.00. The recipient must attend an accred ted four-year college with an approved horticulture curriculum.

Applications and details can be secured from high school principals, gu dance counselors, vocational agriculture teachers or 4-H Club agents. These must be submitted to the Asheville Agricultural Development Council, 420 C ty Building, Asheville, N. C. 28801 by April 1, 1968. The winner will be announced by May 1.

High school graduates of the 18 counties composing the Agricultural Development Council are eligible. These include Avery, Buncombe, Burke, Cherokee, Clay, Graham, Haywood, Henderson, Jackson, Macon, Madison, McDowell, Mtchell, Polk, Rutherford, Swain, Transylvania and Yancey counties.
