**BEGINNING** at a White oak on the South side of Plum Branch Road, and running South 22 degrees 45 minutes West 180 feet to a stake; then South 63 degrees 15 minutes East 61 feet to a stake; thence South 26 degrees 30 minutes West 142 feet to a stake; thence South 14 degrees West 213 feet to a stake; thence South 5 degrees 30 minutes West 72.5 feet to a stake on the outside line of the Millie Hensley tract at Mon Harris' line; thence South 79 degrees East 24.5 feet to a stake Kivett Styles' corner; thence with the Styles' line North 85 feet to a stake East 303 feet to a stake; thence continuing with Styles' line or fence North 28 degrees East 99 feet; North 39 East 99 feet; North 26 East 165 feet North 33 degrees East 99 feet North 36 degrees East 127 feet to a small sourwood; North 10 degrees East 66 feet; North 34 degrees East 74.3 feet to a stake where a dogwood corner stood; thence North 74 degrees 30 minutes West 77 feet to an iron stake North 73 degrees 30 minutes West 142 feet to a stake North 78 degrees 30 minutes West 58 feet to a bunch of maples near the plum branch road; thence with said road south 86 degrees 30 minutes West 151 feet; South 64 West 154 feet to the **BEGINNING**, containing 7 acres, more or less.

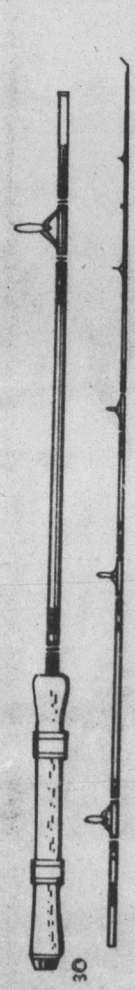

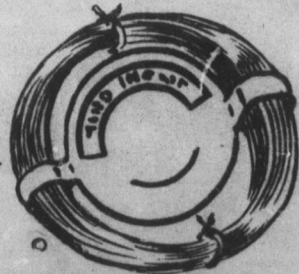

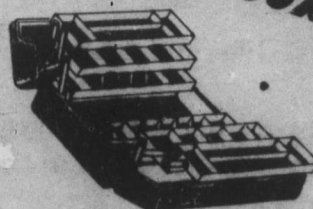
