

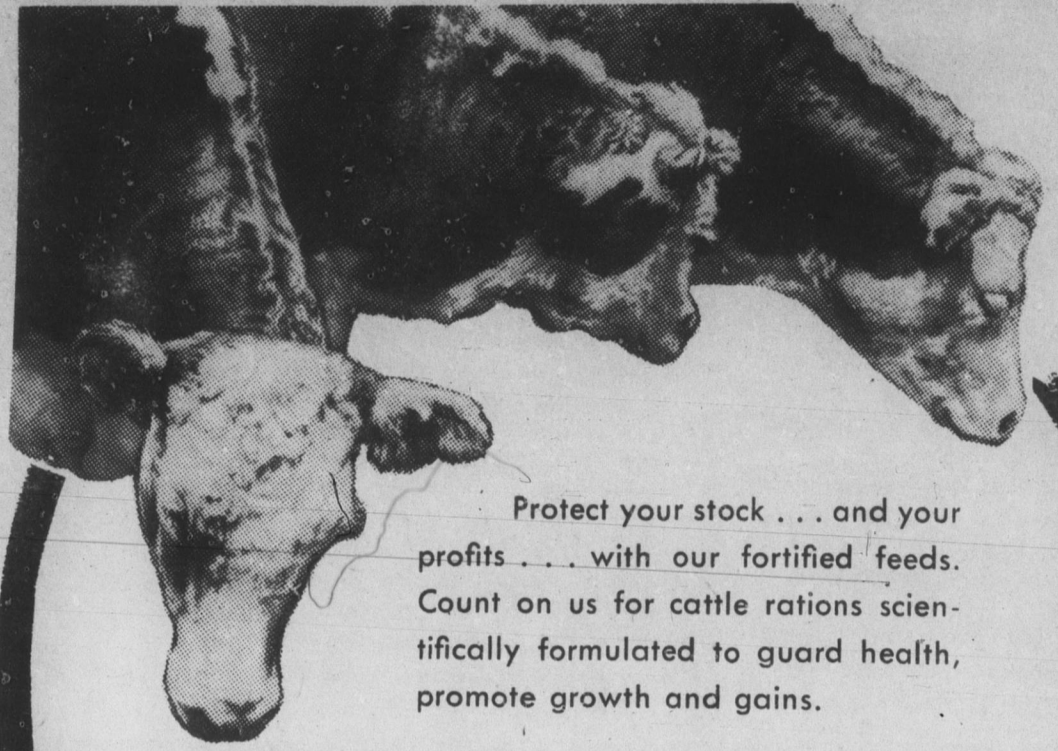
NOTICE OF SALE
