Social Security Questions-Answers

Q. Is it always necessary to go to the Social Security office when we have a question or a problem with Medicare or any other part of Social Security.. or when we need to notify you of a change of address, or anything else that should be reported.. or even when we want to apply for social security benefits?

A. Definitely not. In fact, to report changes of address & any other reportable events or changes you need only telephone the Social Security office.

Whatever your need, purpose or problem a telephone call may quickly get you the desired information or help. Quite possibly it will make a trip to our office unnecessary, and normally will "speed up the service whatever it might be.... including the filing, developement and processing of claims through to payment of berefits.

Oftentimes the social security specialist can get necessary information by telephone to fill out any required forms and will tell applicants what evidence or proofs are needed to complete their claims for benefits. Frequently application forms can be mailed to them for their signature and returned by mail, with the necessary proofs enclosed.

A. You will be eligible for the medical or "doctor bill" insurance part of Medicare, but not for the hospital part.

If your husband signs up for

Medicare as he should in the three months before he reaches 65, then you as well as he can qualify for hospital insurance in addition to medical insurance. He does not have to retire to get the full Medicare protection.

Cut-rate gas in a Cadillac? A recent survey shows more and more car owners are finding gas is just as good at independent dealers — and less costly.

A psychological hang-up involving "status" is costing American car owners a lot of money, according to findings by a leading independent oil company.

The reason is best explain-

The reason is best explain ed by this question:

Would the proud owner of a brand new Cadillac, Continental or other expensive car fill up its tank with "cut-rate" gasoline?

In years past, the answer has been a resounding "no". And so Kayo Oil Co. of Chattanooga, Tenn., which has built a sizeable business selling the same quality gasoline as major oil companies, but at lower prices, decided to find out why.

On the basis of its exper-

On the basis of its experience with customers in 17 states, and the experience of other independent oil companies with similar operations, Kayo found that the average motorist didn't really understand how many different things affect the level of gasoline prices.

"The general feeling," said a company spokesman, "is that if gasoline is sold at a lower price, it must be of a lower quality. The average motorist

doesn't realize that the independents can afford to sell the same gasoline cheaper because they are economizing elsewhere.

"Major cil companies spend millions on national advertising. Credit cards and trading stamps are additional expenses, and all these things figure in the price the customer must pay for gasoline.

"Offering mechanical services, parts, accessories, tires and free road maps also costs money. The independent who specializes in doing nothing but pumping gasoline and adding oil can afford to charge much less because he doesn't have all these other expenses."

Kayo found, however, that with the rising price of everything, motorists are becoming more and more concerned about how to cut corners.

"Of course, there will always be some who just don't want to be seen putting low-priced gasoline in their high-priced cars, even though they know the gas is just as good," the Kayo spokesman added. "But most people, we think, would rather save money than enjoy that kind of 'status'."

Q. I'm already getting social security benefits and will be 65 years old in July. When should I sign up for Medicare?

A. Since you're already a social security beneficiary you will be automatically entitled to the hospital insurance of Medicare beginning with July, the month you become 65. In other words, you wont need to do anything to get the hospital insurance part, effective that month.

But assuming you also want the voluntary medical insurance coverage, just complete and return the enrollment card you will get in the mail shortly before your 65th birthday. Be sure to mail or take the card to the Social Security office before the first of July so you' Il have this doctor bill insurance protection beginning that month.
