Free Mumps Vaccine

The Yancey County Health Department will now be offering free mumps vaccine at the regular Monday immunization clinic for a limited time only.

Although mumps is usually a mild disease, it may occas sionally have serious complications. Meningoencephalitis has been estimated to occur in 10 percent of all patients, and infection of the reproductive organs in 20-30 percent of adult males. Other complications can be muscular weakness, facial paralysis, arthritis, hepati tis and deafness.

Children have a natural immunity up to the age of 1 year. This vaccine will be
