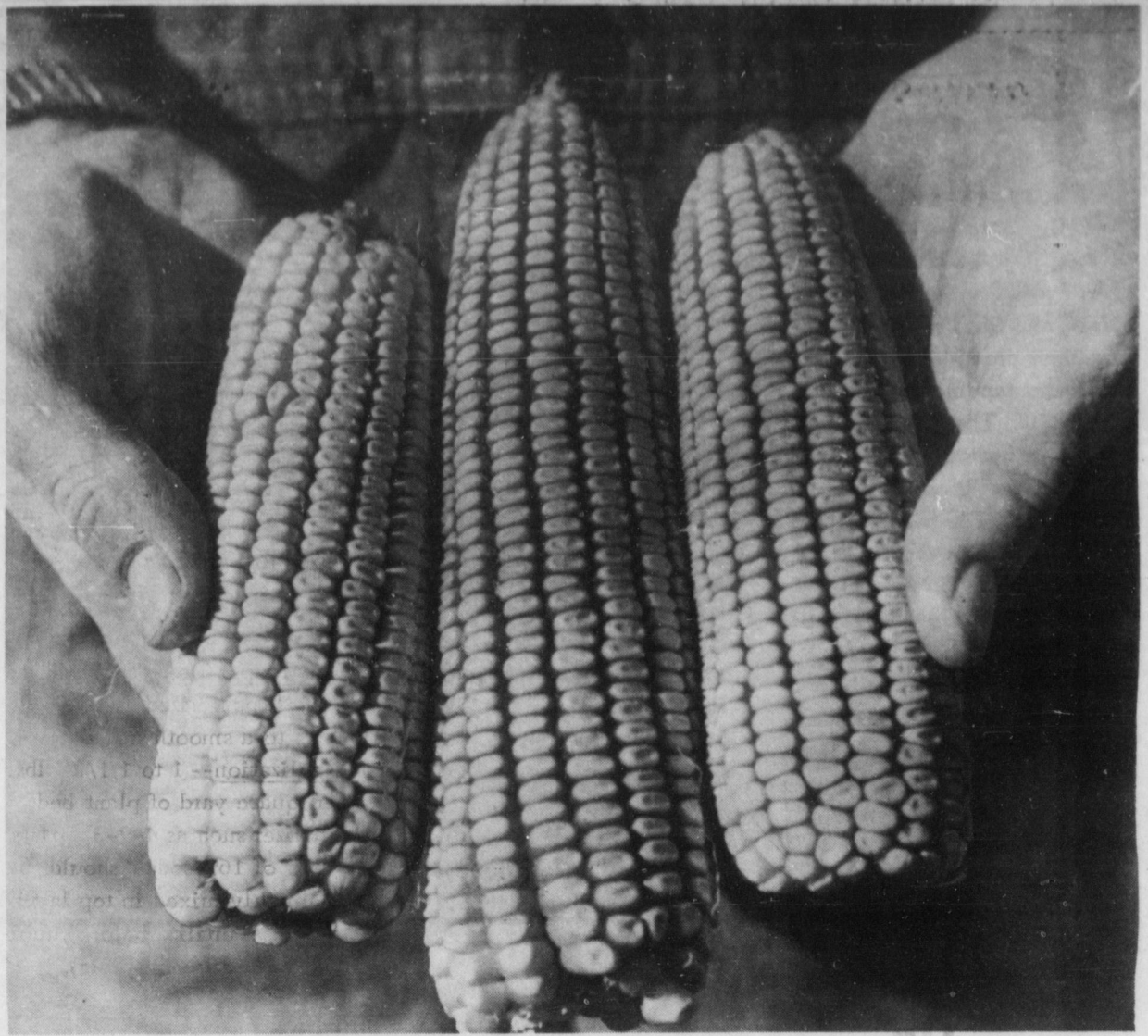


Corn Clinic Scheduled Here

The Yancey County Extension Service has scheduled a Corn Clinic to be held March 31st at 7:00 p. m. in the Court-house. William C. Bledsoe, County Extension Chairman, pointed out that this clinic was planned at the request of farmers. The purpose of the clinic is to inform landowners and farmers of what the corn situation will be this year and how to cope with Seed, Weed and Cultural problems in rela-

tion to the Southern Corn Leaf Blight. The meeting will be conducted by Drs. Stuart, Wells and Lewis, specialists from the North Carolina State University. Farmers, seed dealers, seed salesmen and the general public are cordially invited to attend and participate.

The outbreak of Southern Corn Leaf Blight in the United States during 1970 caused a greater production loss on a single crop in one year than any similar event in the history of agriculture. It is expected that the blight will be a major problem with producers this coming season but hopefully not a problem in 1972. "Our College people, the Extension Service and the seed people have a storehouse of useful information for our farmers," Mr. Bledsoe pointed out, "and I hope our farmers will take advantage of this opportunity to get it."
