

# Fund Drive Underway For New Avery Library

A fund drive has been announced this week to raise \$10,000 in local funds for construction of a new Avery County Public Library to be located off the Town Square in Newland.

Working plans for the Library have been finalized and an artist's conception of the completed structure appears above. Some statistics might be in order to compare the projected library with the present facility.

The new library will contain 6,426 square feet as compared to the present 961 square feet. There will be shelving facilities for more than 26,000 books as compared to the present inadequate 7,000 books. The children's area will be adequate to take care of the present weekly Children's Hour, one of the most popular features in the library, expanding totally inadequate present area from 40 square feet to more than 1000 square feet. In addition a large meeting room will be constructed within the facility that will seat 75 persons and be available for

community group meetings as well as library sponsored programs, art shows, exhibits, and like events. Film and slide projection facilities will be available in this room.

A special music room will be provided with listening facilities for an expanded record and tape collection and storage for more than 2,000 records maintained therein. Local

history as well as the reference needs of patrons will be housed in the Robert Morrison room, memorializing that late citizen of Avery County whose generosity under the terms of his will made the possibility of such a fine building more of a reality.

The entire structure will be carpeted, electrically heated and air-conditioned with air filtration for the protection of materials and the comfort of patrons.

Funding the building will be from Library Services and Construction Act funds of approximately \$50,000; Appalachian Regional Commission funds of \$40,000; the Robert Morrison Trust of \$50,000; an

incentive grant from North Carolina Fund money dispersed by W.A.M. Y. Community Action office of \$5,000. Under the terms of the Morrison Trust \$10,000 must be provided from local funds or contributions and it is to meet this requirement and to make this fine community asset become a reality that all interested citizens are urged to contribute in the drive.

A June commencement date for construction is the goal at the present time.

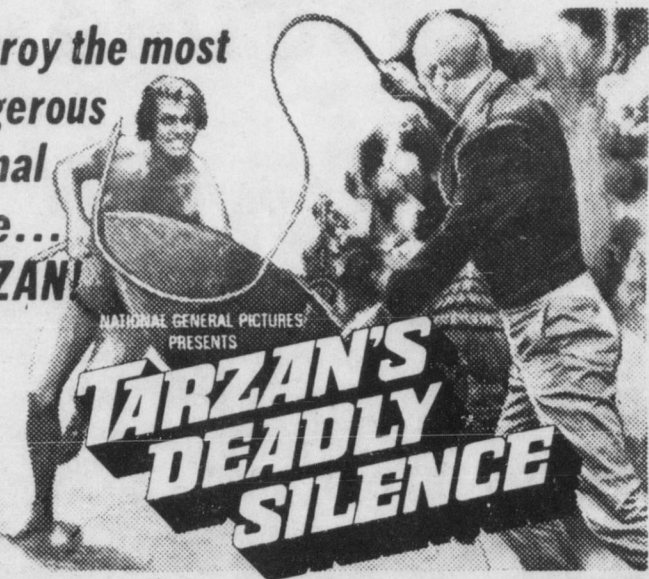
