BBB Warns Taxpayers

R.E. Hitchcock, Manager of the Better Business Bureau, today urged taxpayers to be cautious in the selection of a tax preparation firm if it is necessary to use a profes sional service in the prepara tion of an income taxreturn, He noted that the Federal . Trade Commission has recent ly provisionally accepted a consent order which prohibits one such firm, H & R Block, from making certain adver tising claims.

According to Mr. Hitobcock, the proposed complaint alleged that, despite impli cations in the Block organization's advertising, it does not reimburse a tax payer for all. payments he must make! in addition to his initial tax payment if the additional payment is the result of an error made in the preparation of the tax return.

In addition, the FTC complaint alleged that Blockpersonnel are not certified - to practice before the IRS in the event that a customer's tax return is audited. THERE'S BIG GAME
