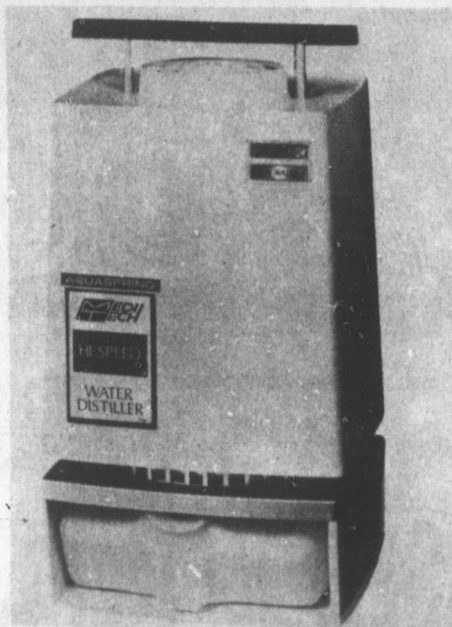
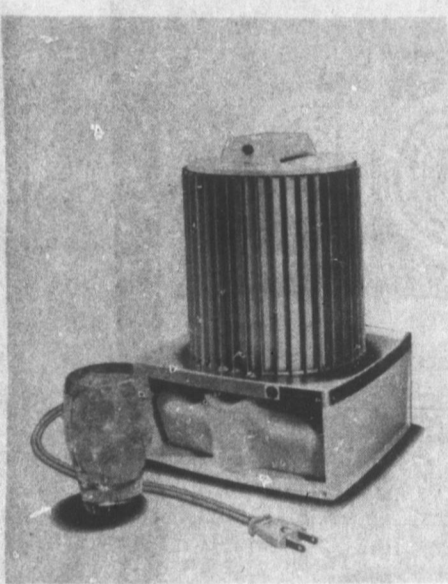
chairman of the committee on the restoration of the street signs, there was no report forthcoming. It is to be hoped that progress can be made soon to remedy the situation.
