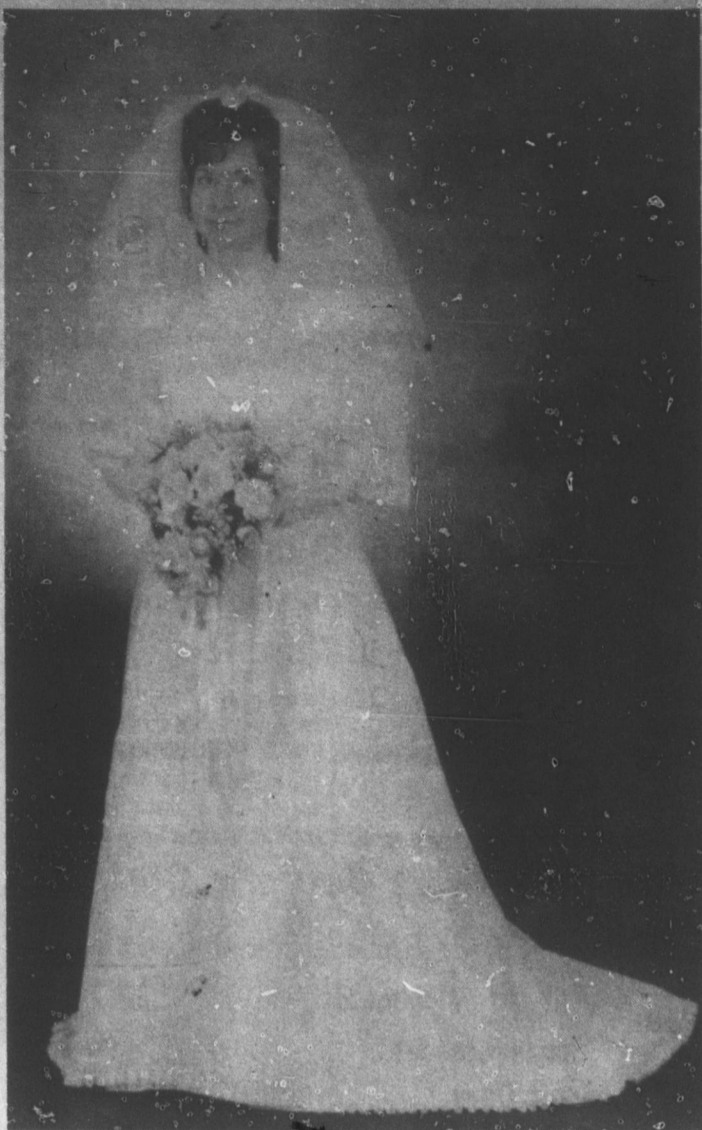
Mr. Warren was his son's best man. Ushers were T. L. Cathy of Candler and Jackie McElrath of Swannanoa.
