

Mrs. Killian, 76, said that she was walking toward her garden at approximately 7:00 p.m. Friday, and when she reached up to break a limb from a tree the snake struck her on the right leg just above the ankle. She said the snake was apparently lying in some bean sticks, stacked at the base of the tree

Mrs. Killian did not see a doctor until Saturday morning. She said that her leg began to swell after the bite and that she put table salt on the wound. She said that the pain began to worsen and that the ankle continued to swell, and she decided to go to a doctor.

A nurse at the hospital said that Mrs. Killian leg was swollen badly when she came to the hospital Saturday.
