FOR NATIONAL CHAIRMAN.

In discussing the various possibilities for the national chairmanship, there is a tendency on the part of the administration organs to regard the chief necessary qualification to be able to hold up the big corporations of the country for campaign funds. The ability to do this is generally pictured as the chief secret of the success of the late Senator Hanna as the Republican chairman.

While it is unquestionably true that, in the campaign, he managed, Senator Hanna was able to secure very large campaign contributions, it seems to us only fair to say that this was but one feature contributing to his success.

It may be possible for the Republicans to find some man with the ability to "fry the fat" out of the trust magnates for the benefit of the Republican campaign fund, but it will be extremely difficult to find anywhere a man possessing the same ability as Senator Hanna in handling the party machinery.

The fact is, there are few such men; and so far as can be discovered, practically all of these are at heart opposed to President Roosevelt.
