Investigation Stymied in Jones County Mystery; Howard Still Critical

Jones County Sheriff Brow Yates and SBI agents assisting in the investigation of the mysterious shooting that claimed the life of 57 Holding Reunion year-old Russell Mills and has 55 Members of the James year-old Rudolph Howard in Duke Hospital say they have about "run out of leads".

Howard, who was mowed down by four slugs from a .22 caliber weapon, has not spoken' since he lapsed into a coma shortly after arriving at Lenoir Memorial Hospital in Kinston on the niight of September 10th.

One of the four bullets penetrated his upper left lung and caused its collapse. Howard, already a chronic asthma sufferer, has had an extremely difficult time and on Monday of this week at Duke Hospital, where he was transferred on the 12th, attendants feared he was dying. During the night, however, he improved slightly, but is still classified as in extremely critical condition.

The lack of the murder weapon, absence of other clues and inability of Howard to talk have left officers with little more than interviews with people in the neighborhood where the crime was committed. Practically everyone in the area between Comfort and Hargett Crossroads had been interviewed in the hope that a motive, or some clue might be found. So far none has been found.

Charlie Mack Koonce that he did not know who had shot him. Koonce, who lives less than a quarter of a mile from Howard's statiion where the assault took place, was bringing Howard to the Kinston hospital.

Mills died from a bullet wound in the head, and was found in his car that had been stalled in a ditch about three miles west of the filling statiion. Officers believe that the man who killed Mills and so badly wounded Howard drove Mills' car to that point. Mills was lying on the right floorboard of the car and practically all the blood inside the car was on the right side of the seat and in the right floorboard area. Blood believed to have come from Howard was smeared all along the right front
