county commissioners of Jones over having projested the rentals paid by the several court house tenants. No one's memory recalls any occasion when he has inquired either individually or collectively of these rentors on the subject of whether their rent was high, low or outside.

Perhaps it is nothing more than coincidence that this issue is being raised by Commissioner Jones at a time best calculated to embarrass certain Jones County candidates for public office. If his motives are purely political they might be forgiven, since it has been said that all is fair in love, war and politics.

But if Commissioner Jones is simply bringing this issue up after six years on the board as an act of "righteous indignation" then he is exposing himself to the obvious criticism of having aided and abetted in what he now infers is an abuse. If it is bad now—which I deny—then it was bad six years ago when Jones first got on the board of commissioners. He is either very slow to learn, or very slow to act if it has taken him six years to reach his negative point of action in this months outbursts.

If it has taken Jones six years to discover what the court house rentals are and six years to reach the conclusion that they are too low, the question obviously comes to mind: Is Jones alert enough to be a "watch dog" over the affairs of the county?
