### **Prostitute Sues Madame for** \$75,000 After Being Beaten

Eileen Hopkins Simpson, who 20 years as clerk. says she was a prostitute in the house operated by Mrs. Eunice McLawhorn just south of Kinston on the New Bern Road, last week filed suit for \$75,000 damages against the alleged madame for injuries in a beating that she says she suffered at the hands of Mrs. McLawhorn and other occupants of the house late in April. She seeks \$50,000 compensatory damages and \$25,000 punitive damages.
