Crap Game Murder Trial Underway in Kinston The Tuesday afternoon session of

Lenoir County Superior Court was spent in choosing a jury from a special venire of 100 jutors to hear first degree murder charges against 49 year-old Garland Purvis of Kinston route 1.

Purvis faces the capital charge for the slaying last October of 38 year-old Julian, Baysden of Kinston at a drive-in cafe just north of Kinston on the Greenville highway.

Purvis told investigating officers at the time of the slaying that on the night of the shooting he had been acting as "bouncer" for a crap game that was going on in the back of the cafe building.

In this crap game, Purvis said Baysden lost a considerable amount of money and became angry. Purvis said he asked him to leave and then later after the game had broken up an argument took place between them outside the cafe, which ended in the shooting.

Purvis claims that he was acting in self defense, but there was no evidence that Baysden was armed, and Purvis was not injured in the argument that preceded the slaying.

Barrus Bids Low on 3 of 36 Road Projects

In bid openings held by the State Highway Commission Tuesday in Raleigh Barrus Construction Company of Kinston bid low on three of the 36 projects on which bids were taken.

The total cost of all 36 projects ran to just over \$4 million.

Barrus had total bids of \$275,122 .-90 on three projects; \$86,750.80 for 4.94 miles of paving in Jones and Lenoir counties; \$97,094.80 for resurfacing 14.6 miles in Onslow County and \$90,277.30 for resurfacing 18.5 miles in Sampson County.

Attendants at Lenoir Memorial Hospital in Kinston say Lowery suffered contusions and bruses in the chest area and injuries to his right leg and right arm.

Ervin suffered head injuries and also injuries to his right leg and his right arm.

Lee suffered a busted lip and the loss of some teeth, but he was not hospitalized.

No indictment had been made Thursday morning but the investigation is not closed.
