The dilemma of decision of the number one topic of current com-munity interest in Chapel Hill is that of enforced extremism.

That is to say, in the eyes of many persons vitally concerned, and of beholders locally and abroad, there is no decision open as to one's sentiments on a public accommodations ordinance for Chapel Hill except those at the extremes.

If one is against it, regardless of his motivations, he is lumped with the extreme conservatives, with whom he may have little or nothing in common.

If he favors it he is lumped with the extreme militants, with whom he may have only a moral, rather than a practical and temperamental

While he may agree with the objectives and ends of either extreme he may not in all good conscience agree with the means to that end. And if he does not agree with the means to that end, the futility is that he can in this instance find no home with those whose convictions he basically shares.

This internal tug-of-war is continuing within the conscience of many persons of equally good will. The provocation of public conscience on this issue of basic morality and practical goals is good. All humanity should be constructively disturbed over the unjustified intolerance of man against his fellow man.

But the same spirit of Christian brotherhood that is legitimately claimed by those who drive militantly toward their honorable goals should also grant to those persons with whom they do not agree as to means to the same end, a fair share of the integrity which the militants automatically attribute to themselves.
