

Rhubarb-Strawberry Jam

Bhubarb-Strawberry Jam 6 cups (about 1½ lb.) diced fresh rhubarb, 3½ cups (1½ lb.) sugar, ½ cup water, and 1 package (3 oz.) strawberry flavor gelatin. Thoroughly mix rhubarb, sugar, and water in a large saucepan. Cook and stir over high heat until augar is dissolved — about 2 minutes. Cover and cook over medium h eat, stirring occasionally, until rhubarb is tender. Then remove cover and boil 12 to 15 minutes longer, or until thickened to sauce consistency, stirring occasionally. Remove from heat; stir in gelatin until dissolved. Skim off foam with metal spoon. Ladle quickly into glasses. Cover at once with % inch hot parafin. Makes about 6 medium glasses. Note: This jam is best if used within one month. Jam
