Carolina Telephone To Eliminate Ten-Party Service In Pollocksville


Carolina Telephone has an-nounced plans to eliminate all ten-party service in Pollocks-ville and replace it with fourparty service. This conversion is part of a long range plan which will eventually result in the elimination of ten-party service throughout the operating terri-tory of Carolina Telephone.

D. F. Holliday, local manager for the telephone company, said that the changes will become effective on June 16, 1968. The rates for all four-party service in Pollocksville rural areas were reduced in August, 1967.

"This will be a major step forward improved telephone service for rural subscribers of Pollocksville because it will reduce the number of telephones on the same line to a maximum
