TAMALE MUFFINS

12 muffins

- 1 cup enriched self-rising corn meal
- 1 cup enriched self-rising
- 3 tablespoons chili
- 2 eggs, beaten
- 1 cup tomato juice
- 1/4 cup oil

Stir together dry ingredients. Blend eggs, tomate juice and oil. Add liquid all at once to corn meal mixture, stirring until smooth. If necessary, add more tomato juice to make a medium thick batter. Fill greased muffin cup 2/3 full. Bake in preheated 425° oven 15 to 20 minutes, or until done.

*Spoon flour into dry measuring cup; level. Do not scoop.

A: Not much, really. Such terms are sentimental, not logical or reasonable concepts. It is difficult enough for most of us to achieve an intimate relation (i. e. brotherhood) with members of our family. Rarely do we have more than a very few thorough-ly reliable friends who might be considered "brothers." These terms, as you must recognize, are part of the equality myth. We can try to respect and be courteous to people but we cannot achieve "brotherhood." The idea is fatuous.
