

By means of this unique test on a passenger car rear axle, set up in the laboratory of the Chevrolet Gear and Axle Plant in Detroit, twelve gauges measure every possible deflection assumed by the parts in the rear axle under a given load condition. A weight is hung on the end of the drive shaft that corresponds to a maximum load on the axle during actual driving conditions. All movements or deflections of the drive shaft, pinion and ring gears, and axle shafts are then read simultaneously. Such minute and constant checking results in better mounting of bearings, that serves to prolong axle life and insure more satisfactory service. In this picture are Leo B. The District Health Department announces the following grades for local dairies for the period ending January 31, 1938:

1. Mrs. E. B. Foushee - Grade A. 2. Mr. V. O. Blalock - Grade A. 3. Dr. B. A. Thaxton - Grade D.

In accordance with a recent amendment to the milk ordinance, Quail Roost Dairy and Roxboro Dairy Products Co., which handles Quail Roost milk, are not under supervision by the Health Department. Their milk is produced under other supervisions in accordance with standard requirements, but falls short of Grade A requirements temperatures and making bacterialogical examinations of the milk at

time of delivery. In announcing these grades, Dr. A. L. Allen, Asst. District Health Officer gave high praise to the local dairies making Grade A, stating that they have given the health department splendid cooperation, and are producing milk of the highest sanitary quality.
