

UNHAPPY RICH COUPLES FLOCK TO MEXICO FOR EASY DIVORCES

Mexico City, February—The fastest thing in this republic is a divorce. Here where "Manana usually means anywhere from a month to six months in everything else in the matter of getting rid of an objectionable spouse, it literally means tomorrow.

By this it is meant that it is possible for one to come here, go through a few essential formalities, occupying say twenty-four or forty-eight hours, return to the States and within one month receive through registered mail a duly certified document of separation, or complete divorce.

Primarily the trick is the establishment of residence. This is done upon arrival and not after the lapse of a month, or two months as the case may be. Next comes the appointment of "a power of attorney," a celebrated institution. This person becomes you in every legal sense of the word. He may appear in court for you, just as well or better than you can appear for yourself, sign your papers, procure the decree and forward it along.

Divorces Are Legal
So far as Mexican law is concerned it is just as legal in the states of Morelos, Sonora and Yucatan as if the complaining party had actually established himself in a hacienda and remained there, attending court daily taking part in the civic life of the community and otherwise becoming a resident.

As to the legality of these divorces in the United States that is a moot question. Those in Sonora and Morelos have never been passed upon by the courts, so far as is known here. Those in Yucatan have been in the state of New York and declared illegal. However, under treaties existing between Mexico and the United States there is a clause which says that decision of courts in the respective nations shall be considered legal by both.

There Are Pitfalls
As may be imagined, in this Utopian state of affairs for unhappy couples, there are many pitfalls which do not appear in the texts of the laws. For instance when a party seeking divorce in the State Yucatan arrives there by steamer from New York the port authorities require a deposit of \$500 before landing. This is quite aside from the legal fees. It is stipulated that if the divorce is granted the money goes into the treasury, if not it is refunded. In the case the complaining party is a woman the authorities require also a certificate from the deserted husband giving his permission, duly certified, that his wife has gone to Mexico with his consent. Husbands escape this penalty. Many are the sobs when pretty young women trip gayly down the

gangplank at Progreso and back up again because they have not the \$500 or a permit to be absent from home. On the other hand a young man from Texas has been divorced in Yucatan three times within the last seven months, and is now seeking another.

Will Abolish Law.
He will have to act quickly as the new governor, taking office February 15, has publicly announced that he would annul the law as his first official act, and there is every reason to believe that he will do so, as he is the foe of the party passing the act. This will probably save the courts in the states any number of appeals.

In Sonora and in Morelos the laws were drawn with more care. Both require notice to the absent party. In Sonora the courts require that a notice be published in a newspaper in the actual home city of the party, allowing a period of thirty days for the absent party to respond. In Morelos of which Cuernavaca is the capital and divorce center, due notice is considered publication in the court record of that city, which by no manner of means is likely to find its way to the attention of the absent party. Grounds for divorce in both instances are unlimited. They range anywhere from a desire of either party to separate to an elopement with the butler. Domestic intractability of any kind is quite sufficient. As may be supposed most divorces take the milder form, just an agreement to disagree and there is nothing in the court record to reflect on child or absent party, or to excite a curious public.

Records Are Secret
"Naturally many persons take advantage of this situation," said Harry Grace, who established himself as the divorce king of Mexico and presides over a large colony here, making daily excursions to Cuernavaca, three hours by automobile. "They come and go and no one is any the wiser. Many of them have tried time and again to secure divorces in New York and some of the other states where the law is strict. They find that they can not do so without besmirching the good name of a wife and innocent children. Rather than do this they endure unspeakable conditions until they can get away for a trip to Mexico. When a divorce becomes necessary, and it is always lamentable, I believe that it should be done quietly and in this way.

"The court records in Cuernavaca are closed book. Parties seeking divorce usually withhold their names and identify except in the actual filing of the papers. These come before a judge, without a jury. All declarations are written. There is no verbal testimony. There is already a large colony at Cuernavaca, a delightful resort, and as soon as hotel accom-

modations improve this colony will exceed the celebrated Reno."
Financial Settlements
There is another angle to the laws however, which his not equitable and which will prove hard to remedy. That is the question of alimony and the care of children. Parties seeking divorce have all the opportunity to employ fraud as to their incomes, the amount necessary for the support of wives and children. The sums in the law are fixed on Mexican incomes for the average person, extremely inadequate for support in the states. And, of course, the Mexican courts have no way of enforcing payment in the states.

On the other hand most of the divorce colony is made up of wealthy persons who previously have entered into financial agreements and mutually agreed upon Cuernavaca as a quick and efficient way of separation without scandal.

Parade System Works

The Governor reached this conclusion along about the time he issued a statement declining clemency to fifteen men convicted several months ago for attempting to forcibly take a prisoner from the Buncombe county jail after a thorough investigation by Pardon Commissioner Sink. Following this declaration His Excellency requested Mayor Cathey of Asheville to inaugurate some measure of relief for the families of the offenders who are now or may hereafter be in distress. The Governor would not have the innocent punished with the guilty in

Radio Plan Endorsed
Governor McLean's radio plan, designed with the intention of making rural schools community centers, was enthusiastically endorsed by the heads of twenty-one divisions of the state government during the week and plans for effective action are soon to be worked out. It is expected that not less 500 schools will arrange to install radio sets if accorded the privilege of connecting with the State broadcasting station.

The subject of working Saturdays it is said, will come before the Salary and Wage Commission on March 15. There is little probability that the departure from present practice will be taken. While the ruling of the Commission on holidays has aroused considerable opposition among those affected, it is not be-

lieved among officials there will be any further revisions of working conditions.

Forest Fires
The forests of North Carolina are second to none in the opinion of W. C. McCormack, assistant state forester, who came here from a similar position in Idaho the first of the year. Mr. McCormack believes the forests in Eastern North Carolina are constantly subject to fire damage because of brush. He is making a tour of the state to become thoroughly acquainted with conditions.

Governor McLean says a man's color will be no bar to his obtaining justice from the Executive office. Referring to Alvin Hansel, sentenced to die for an attack, the Governor said if he were convinced Hansel were innocent he would pardon him as quickly as the "most outstanding white men in North Carolina." Mansel's case is on appeal to the Supreme Court but it is expected that in the course of time it will be taken to the Governor.

Lower School Fire Rate.
The fight for lower insurance rates on North Carolina school houses was taken to New York this week before the Southeastern Underwriters by Stacey W. Wade, insurance commissioner. The rates were increased some time ago without Mr. Wade's sanction.

The proposed national park in the western section of North Carolina was the subject of addresses Saturday night at a dinner to the State Park Commission. The commission travelled over North Carolina last week presenting the idea to the people, especially those of the East who are not as familiar with the proposition as those nearer the proposed park.
