PRICE OF BLOOD SET BY MEDICOS

St. Louis Hospital Heads Set Standard Price for Transfusion Fluid

St. Louis—Blood from the human body will be sold at \$25 a half pint for transfusion purposes under a plan which has been approved by leading hospital authorities in St. Louis.

When the plan is placed in operation, St. Louis will be the first city in the world to have a centralized list of blood donors according to doctors behind the movement here.

A committee appointed by the Community Council to study the question of donors of blood for transfusion, found that in emergency cases, it is imperative that a list of such donors be on hand that they may be called upon immediately.

"The committee expects to standardize the fee for donors of blood," Dr. J. J. Singer of the Barnes Hospital, chairman of the committee, declared. "The City Hospital and Barnes have been paying \$25 and we hope to make this the customary price.

Supply Both Sexes

"Formerly medical and theological students have been about the only material available and the demand for blood transfusions is on the increase all the time. We will be able to use both men and women."

In blood transfusions it is necessary to type the persons and to classify their blood as type 1, 2, 3, or 4. In transfusion it is necessary to use the same type of blood as that of the person who is to receive it.

Often in the case of active hemorrhages or where much blood is lost in accidents, it was pointed out, quick action is imperative if a life is to be saved.

During the summer months especially when medical students are away from the city, it has been a hard problem to obtain blood for transfusion purposes.

Under this plan, the blood donors after being examined and classified, will be listed and a list will be placed at the Central Registry for Doctors and Nurses and one at each hospital in St. Louis.

No Loss of Life
"During the summer months when
medical schools are not in session,
there is difficulty in obtaining subjects," Dr. Singér continued. "All
over the city doctors have been unable to obtain the right donor at the
proper moment and in many cases
have had to see their patients die for
want of blood.

"Loss of life on this account will be a thing of the past when this plan is in operation. We feel sure that hundreds of persons will respond to the call with an offer to be on the list of donors for emergency."

Only half a pint of blood is taken

this amount it is said, is not injurious if not done more often than every one two or three months.

Laboratory tests of the donors will be made in the Bethesda Hospital, City Hospital, Barnes Hospital, St.

Children's Hospital and the Barnard Skin and Cancer Hospital. Leaders in the movement hope to encourage many to have their names placed on a list of free donors.

Asheville's Railroad Hopes

The Asheville Times reports that the Chamber of Commerce of that city is negotiating with both the Seaboard Air Line and the Louisville & Nashville to make track extensions into the mountain city, and The Times understands that the roads are inclined to "favorable consideration." It is apparent under developing conditions that extensions of the kind will be necessitated within a short time and it is known that the Seaboard has had under decision the advantages of an extension of the road from Rutherfordton, according to the plans of the original builders of the line. More recently, in view of the Florida boom and its transferrence to western North Carolina this season, there has been renewed talk in connection with the Seaboard extension. The Observer's information is that President Warfield is anxious to make the proposed extension, but there seems to be a traffic arrangement with the Southern which stands somewhat in the way. If the Seaboard and the Southern can work out a new deal agreeable to both roads, the way may be opened to the long-desired extension westward of the Seaboard.
