For the control of brown rot. For the apple use Bordeaux mixture spray, prepared by mixing the materials in the following proportions: Copper sulphate (bluestone), 3 pounds; Fresh stone lime, 4 pounds; Water, 50 gallons; Arsenate of lead (powder), 1 pound.

For the Peach. Either self-boiled lime sulphur, or the dry-mix lime sulphur spray should be applied to the peach. The self-boiled lime sulphur is composed of 8 pounds of fresh stone lime and 8 pounds of sulphur to 50 gallons of water.

porters. It is important to use a good quality stone lime that slakes readily. Mix the sulphur with enough water to form a thin paste, making sure to break up all lumps. The lime is placed in a barrel and enough water poured on it to almost cover it.

With each 50 gallons of spray, mix in one pound of arsenate of lead powder for the control of worms and the spray is ready to apply. This spray may be used on the apple in case there are only a few apple trees to be sprayed.
