Both teams exhibited a fine spirit of sportsmanship throughout the game. Belwood center, Peeler, was greatly appreciated when he plunged through the Casar line and threw them for a loss every time. Belwood was victorious the following Friday when they motored to Casar for their second grid game. Cook again exhibited his grid ball ability by running 30 yards for a touchdown, only to be called back by the referee because his speed was temporarily checked by two Casar players which he successfully eluded.


