here are two major classes of Long Distance Service

"Person-to-Person" Calls

A Person-to-Person call is one where you specify that you wish to talk to a particular person at a distant telephone. The rates for this service are the same at all hours, whether you talk during the day or night. Charges may be reversed on all Person-to-Person calls.

"Station-to-Station" Calls

A Station-to-Station call is one where you ar willing to talk to anyone who answers at the distant telephone. After the called telephone answers, if you wish, you may then ask for some particular person, but the charges on a stationto-station call begin when the distant telephone answers.
The rate for Day Station-to-Station service is lower than the Person-to-Person rate and in the evening between 7 and 8:30 the Station-to-Station rate is about one-fourth less than the Day Station-to-Station rate. Station-to-Station calls made between 8:30 P. M. and 4:30 A. M. cost about half as much as Day Station-to-Station calls. Charges may be reversed on Station-to-Station calls when the rate is 25c or more.
