





"The First National bank had a capital stock of \$250,000; surplus of \$500.000, making three-quarters of a million dollars capital and surplus, besides a comfortable balance of undivided profits. Last year, under the direction of the National bank examiner, we charged off practically \$260,000 as losses on notes of people or corporations who had failed or were unable to pay. This was charged against the surplus and undivided profits account. The bank now has, after charging tucky, announced after appearing off all of these notes, \$250,000 capital, \$250,000 surplus and \$42,000 undivided profits, making a total of \$542,000-over a half million dollars to protect the depositors against any other losses that may have to be charged off. Of course all of these notes charged off still belong to the bank and with the return of normal times many of them will be collected.
