Sentell Murder Trial Set For Next Week

Judge Harding to Open July Term Here on Monday; To Rule on Charges of Violence.
From the tawdry romance and bloody tragedy of Louis Sentell and the girl known as Florence Jones through a welter of vicious cases including rape, seduction, assault and burglary, the July docket of Superior court, opening here Monday, is smeared with sensationalism.

Charged With Murder.
In the Sentell case, a Byrum hosiery mill worker is charged with the shooting to death with a shotgun of Mrs. William Drake, who was known here as Florence Jones. His case was held over from the last term.

State witnesses in this case will be A. W. Benoy, Mrs. J. B. Williams, Mary Anderson, Frances Anderson, Emily Drake, Clyde Bridges, Clyde Philbeck, Lucy Short, Louise Wilkie and Allen James.

Shot Doctor In Foot.
Sensation seekers yearning for vicarious thrills will become sated if this court is able to proceed with speed. One case of great interest to Shelby people will be that in which J. B. Stroud and Less Laughridge, negroes, will be tried for assault with deadly weapons.

Other cases include: Cline Owens Lee, seduction; Daben Hornfit, alias Darwin Munford, assault with a deadly weapon; Mun Blanton, assault with intent to kill; Oscar McAfee, incest; Jesse Smith, statutory rape; Harry Ross, alias Will Thompson; burglary; George Harvey, disturbing public worship, carrying concealed weapon and assault with a deadly weapon; Ed Richards, assault with a deadly weapon; Louise Lanier, statutory rape; Ed Robinson, public drunkenness and assault with a deadly weapon.

N.C. Parole Racket Exposed By Gill In Report To Gov.

Shows \$1,801 Paid By Twenty-one Convicts

Parole Commissioner Vigorously Condemns "Shysters" and "Influential Fixers."
RALEIGH, July 20.—Reports of a widespread parole racket in North Carolina were exploded with a bang today when Commissioner of Paroles Edwin M. Gill transmitted to Governor J. C. B. Ehringhaus a formal report disclosing results of an investigation of methods of attorneys in securing clemency for State prisoners.

No Criminal Violation
"Canor compels me to say that I have not found any violation of the criminal law in connection with these payments. I have discovered circumstances which may or may not disclose unethical conduct of the part of attorneys of law. I am satisfied in many instances that the attorneys resented the case of the prisoner fully and fairly to the clemency office and in every way in a most ethical and commendable manner."

Condemns Shysters
The Parole Commissioner vigorously condemned the so-called "shyster," or "fixer" who claims "great influence with Governors, Judge and Solicitors, and tantalizes the prisoners with hope of freedom and thereby extorts from him the little money he has. Those who would prey upon the prisoner population in this way deserve condemnation of all good people, and their taste may be well termed 'a traffic in human misery.'"

Funeral Today At Sandy Plains

Electric Storm Swoops Down On New House Community With Intense Fury—Wind Damage
One life was snuffed out, a home and barn burned by three distinct bolts of lightning in the New House Community Thursday afternoon during a thunderstorm which was accompanied by high winds and did considerable damage to trees and crops.

Robert Jones, age 21 was plowing in the field with his father when he was struck and killed instantly as well as the mule he was plowing. The plowstock was splintered, one flying piece striking his father some steps away. The father, Jesse Jones, was shocked and burned.

Another bolt of lightning struck the barn of Champ Crowder, abductor of Josh and the barn was burned, together with 28 bales of cotton, and a lot of feedstuff. Mr. Crowder had recently sold ten bales of cotton stored in the barn and this had been removed. His cows were in the pasture at the time, so no livestock was lost.

Shoffner Receives Cotton Instructions At Charlotte Meet

Cleveland County will be able to gain 34,285 bales of cotton free of tax, according to instructions received by Bob Shoffner at a meeting in Charlotte Wednesday.
