Farmers Get Many Benefits From School

ELLENBORO, March 31.—School was out recently for nearly 10 farmers who attended ten evening meetings to take a timely course on farming, taught by A. B. Bushong, vocational agricultural teacher for the school.

Those who attended each of the ten meetings without missing one are to receive a free bag of nitrate of soda. The nitrate of soda companies stimulated excellent attendance on the part of the farmers.

The course is already reaping results in the way of better care of fruit trees and an increased acreage in live-at-home and soil improvement crops. One lesson was taught on fruit growing, and three orchards have already been sprayed as the result. An increased acreage of Irish potatoes will be planted in certified seed as another outcome of the meetings.

Each agricultural teacher is supposed to hold meetings during the year to make a course for farmers of his community, and it is believed that these meetings have been helpful to farmers in the past who have attended them.

Reapportionment Of Solons Asked In Day Measure

Would Follow Census Figures Of 1930; Action Deferred By Lower House.

RALEIGH, April 1.—Reapportionment of members of the general assembly of North Carolina on the basis of the census enumeration of 1930, as provided in a bill introduced by Representative N. E. Day, Onslow, was taken up by the committee on senatorial districts of the house Friday, but action was deferred.

Representative Day, himself an easterner, said he opposed the action in 1931, but that it was the right, the just and the sporting thing to do to reapportion on the basis of the 1930 census, as the Constitution requires.

Representative Ward, of Craven, the reapportionment is to be done at the "first" session after the decennial enumeration, and that since it was not done in 1931, nor even in 1933, it would not be Constitutional now.

Representative Ervin, Mecklenburg, suggested and made a motion interposed the objection that the Constitution specifically states that that an opinion as to its constitutionality be secured from Attorney General A. F. Sewell. Representative Faylor, of Pitt, said that would be only the opinion of one lawyer, and that he had an opinion of his own. He offered a substitute motion to report the bill unfavorably, but withdrew it, when assured that he would have opportunity to vote as he pleased after the opinion is secured.

Representative Day expressed the belief that the Constitutional mandate to reapportion was a continuing one and that if not done when specified, they it should be done later.

U. S. Workers Get Salary Up

WASHINGTON, April 2.—Salaries of government employees were restored Monday to their pre-depression level, adding an estimated \$65,000,000 annually to the federal payroll.

Simultaneously with effectiveness of the recent congressional act increasing government wages to the point they stood before the 1933 economy act pay-cut, the civil service commission announced the numbers of workers in federal executive departments was 680,546, the largest since the war period.

The official tabulation placed the number of such workers in Washington alone at 95,517, which is more than at any time since 1920.

The total does not include workers in the legislative, judicial and military branches of the government, nor 339,594 in emergency conservation work.

The all-time record number of executive employees was 917,760 on November 11, 1918, at the time of the World war armistice.
