Under G. S. 105-311, tax listing by mail is permissable. All resident and non-resident taxpayers of Brunswick County during taxable year shall receive their abstracts by mail. New residents moving into Brunswick County after January must list their taxes before a list taker as set out below. Township books with listings will be returned to the Tax Office on the last week of January for listing.

Anyone may list at the County Tax Office in the Governmental Complex at any time during the regular listing period. Listing time will be from 9:00 a.m. to 5:00 p.m.
