Agencies Provided Minimum Of \$186,390 In County Services

While it's sometimes hard to calculate the cost of providing services to a particular client or group of clients, area United Way agencies have tried to do just that.
Their report, released last week by United Way "loaned executive" Joe Bryant, is an attempt to show the level of spending by member agencies in delivering services to Brunswick County residents.

The American Red Cross served at least 505 people during its most recently-documented 12-month period. It spent an estimated \$51,600 offering first aid, water safety and other classes.
Brunswick County residents used more blood than they donated to the bloodmobile program. At Brunswick Hospital alone, 636 units of blood were used, said Bryant.
Eleven clients were served by the Children's Home Society, at a cost of \$71,500, or \$6,500 per client.

DSS To Distribute Food At Complex

The Brunswick County Department of Social Services will distribute commodities provided by the Department of Agriculture from 9 a.m. till 3 p.m. Sept. 26, and from 8:30 a.m. till 1 p.m. Sept. 27 in the public assembly building at the government center.
Butter, flour, corn meal, rice, honey, dry milk and processed American cheese have been allocated to the local DSS, enough to serve about 2,000 households.
Each household wanting food will be required to complete an application form and to have with them their Food Stamp authorization card. They should also bring a container for the food.
Households not receiving Food Stamps can qualify if they meet the income guidelines.
Those receiving Food Stamps who can not be present for the distribution should send their green identification card and a signed authorization card.
Food will be distributed on a first-come, first-served basis.
