

Man Gets Suspended Sentence For Marijuana Possession

A man received a two-year suspended sentence in Brunswick County District Court last week for possession of marijuana.

On March 4 Judge William C. Gore sentenced Jeffrey N. Necessary to 30 days in the Brunswick County Jail, suspended for two years, and ordered him to pay \$100 plus court costs.

Necessary had pleaded not guilty to that charge and two others. A charge of a drunk and disruptive was dismissed, while he was found guilty of resisting arrest, with a prayer for judgement continued. He was assessed court costs.

King Holiday Bill Before Legislature

This week the state legislature is considering a bill that would make Martin Luther King's birthday a state holiday.

It would change one of the paid holidays for state employees to that date, said Rep. David Redwine.

"This would mean an additional cost to the state for the paid holiday for state employees," he said in his weekly report.

Redwine is supporting passage of the bill.

Brunswick County Commissioners have voted to make King's birthday a holiday for county employees at such time as it becomes a holiday for state employees.

Redwine introduced a bill last week that would appropriate funds for the Coastal and Estuarine Water Beach Access Program.

HB 180 would allocate \$1,000,000 to the N.C. Department of Natural Resources and Community Development to continue the program.

Funds for the program were not recommended the governor's proposed budget. However, Redwine said he and other coastal legislators consider the beach access program important to their areas and to the state's residents.

Also last week, the assembly passed an emergency appropriation of \$25 million for the state prison system to build new prisons and help correct the current overcrowded conditions as well as to hire more probation officers. These steps are expected to help prevent a possible federal takeover, according to Redwine.

Rep. Frank Rhodes, a Republican from Forsyth County, introduced a lottery bill that calls for a referendum. It also calls for the lottery to be
