# Golf Community Planned For Northeastern Brunswick

A pair of New Hanover County land developers believe northeastern Brunswick County has been asleep too long

A.V. "Doky" Saffo of Coldwell Banker Hanover Realty Inc. and Jim Teachey of J.T. Realty plan to open a golf course community, with swimming pool and tennis courts, sometime next year

The project is situated between U.S. 17 and N.C. 133 on 900 acres of land purchased for \$2.5 million from L.P. Timberland, a subsidiary of International Paper

This is Saffo's first golf course community. He said he expects the project to cost about \$10 million, with \$3 million going toward construction of the 18-hole golf course.

The semi-private Jackey's Creek Country Club will feature rolling fairways carved from hardwoods. The land is ideal for building lakes and ponds, he added.

Club membership will be free for all community residents and also available to outsiders for a fee yet to be determined

According to Saffo, the community will include about 800 lots for patio homes and townhouses. In addition to properties overlooking the golf course, lakeside and forest lots will also be available at prices ranging from \$16,500 to \$50,000.

Because of its location just across the Cape Fear River from Wilmington. Saffo said he expects the community to be attractive to investors.

Saffo explained that skyrocketing housing costs in New Hanover County turned his sights to Brunswick County, where he has already developed two residential communities near Belville.

He said the congestion and housing crunch in Wilmington will naturally spread southwest into Brunswick County over the next several years, just as similar problems along the Grand Strand in South Carolina have

# Gill Net Seasons To Continue In The State's Inland Waters

A controversial proposal to eliminate gill net seasons in inland waters is not among new regulations for the 1988-89 hunting, fishing and trapping seasons adopted by the N.C. Wildlife Resources Commission.

The regulations were adopted March 14, following a series of nine public hearings at which sportsmen voiced strong opposition to the gill net proposal. In Brunswick County, local fishermen also prevailed upon the Brunswick County Commissioners and Rep. David Redwine to lobby against the ban.

In other fishing regulation changes Monday, the state Commission did vote to make it illegal to alter or change the appearance of game fish while fishing.

Other fishing regulation changes made Monday: Eliminate the diameter restriction of cast nets when used for taking bait fish;

·Establish a daily creel limit of 200 bait fish when such fish are taken under regulations allowing the collection of bait fish;

•Define a fish trap as being a cylindrical- or rectangular-shaped device into which fish swim and

CRC Discusses Coastal Issues Today, Friday At Wrightsville

Development of standards for information signs in coastal waters and ways to address the problem of plastic pollution along the coast are among the topics to be discussed when the Coastal Resources Commission meets today (Thursday) and Friday at the Wrightsville Beach Holiday Inn.

Sessions begin at 9 a.m. and are open to the public.

Today the Commission was to hear six contested cases. At 1:30 p.m. concurrent meetings of the Planning and Special Issues and Implementation and Standards committees were scheduled.

Among other things, the planning committee was to review proposals for addressing plastic pollution pro-

shorelines and work on military airspace issues.

The implementation committee was to review a rule amendment for updating oceanfront erosion rates, to discuss possible changes in rules for the size of decks over wetlands and estuarine waters, consider developing standards for information signs in coastal watrs, and to discuss the rules on floating structures that are not water-dependent. It was also to hear a presentation on aquaculture.

On Friday, the Commission will hear reports from the standing committees and the ad-hoc committees on the Albemarle-Pamlico Estuarine Study and the Governor's Coastal Initiative. The ad-hoc committees were

During February, 779 deeds and deeds of trust were recorded by the Brunswick County Register of Deeds office, providing revenues of \$7,492.

Filing of irregular instruments such as filing of corporations, contracts, financial statements, cancelations of deeds of trust and vital records accounted for \$6,680 in revenues; 36 plats were recorded for \$720; and real estate excise taxes of \$8,579 were collected, for total revenues of \$23,479.

Monthly expenses excluding personnel totaled \$6,546.
