Developing Future Brunswick Leaders Goal Of New Program

Developing and motivating future community leaders for Brunswick County is the idea behind a new program being offered by three local sponsors.

The South Brunswick Islands and Southport-Oak Island Chambers of Commerce and Brunswick Community College are sponsoring the program, Brunswick Leadership for

Approximately 25 people will be enrolled in the 1990 program, with participants to reflect the county's geographic and socio-economic diversity, forming a network for future communication and understanding. The program aims to select potential and emerging leaders who are most likely to give to the community.

Those selected will study community issues such as education. government services, people services and economic development. They will also receive training in leadership skills such as problem solving, group dynamics, visioning, marketing and communication.

The leadership program will con-

sist of an introductory retreat, followed by four day-long sessions held once each month and a closing banquet. At the fifth session participants will share their views of the future of Brunswick County, as well as the leadership skills they have learned during the course of the program.

Sessions will be conducted on fourth Thursdays, from 9 a.m. to 4 p.m., from Feb. 22 through May 24, on the BCC campus.

The lead facilitator will be Rick Smyre, president of Strategic Concepts, Inc. of Gastonia.

A tuition fee of \$195 will be charged those accepted, with employees urged to identify and encourage employees with great potential to apply, and to pay their tuition. A limited amount of scholarship funds is available.

Workshops Offered

Basic methods of soft-shell crabbing and the latest information on shellfish culture will be presented at two separate workshops in February sponsored in part through the UNC Sea Grant College Program.

Sea Grant Marine Extension Agents Wayne Wescott, Bob Hines and Jim Bahen will lead sessions on crab shedding, blue crab biology, peeler identification, harvesting methods, shedder facility designs and marketing at the crabbing workshop Feb. 9.

The four-hour workshop begins at 1 p.m. in the New Hanover County Agricultural Extension Office at the Old Bradley Creek School in Wilmington.

A panel discussion at the end of the sessions will feature experts from Sea Grant and the crabbing industry. A question-and-answer session will follow.

A \$5 registration fee will cover the costs of a soft-shell crabbing manual and other publications.

The latest information on growing scallops and other shellfish will be presented during a shellfish culture conference Feb. 17 at the Crystal Coast Civic Center in Morehead

State Sen. Marc Basnight of Manteo and shellfish experts from along the East Coast will speak on leasing, permitting, current legislation and state-of-the-art scallop culture. Question and answer periods will follow each session.

Sponsors of the one-day event are UNC Sea Grant, N.C. Institute of Marine Sciences, N.C. Fisheries Association and N.C. Division of Marine Fisheries.
