Fisherman Appeals Active Sentence For License Violation

A Bolivia area man last week appealed an active jail sentence he received in Brunswick County District Criminal Court for a boat license violation.

According to the Brunswick County Clerk of Court's office, Judge Jerry Jolly found Johnny McNeil Moore of Route 2, Bolivia, guilty last Wednesday of licensing a commercial fishing vessel that was not registered in the owner's name.

Prior to his appeal, the defendant was sentenced to a seven-day jail term. The case will be heard during an upcoming term of Brunswick County Superior Court.

Court documents indicate that Moore was charged Oct. 21, 1989, by N.C. Marine Fisheries Officer Dale Hewett. The citation was served on the Calabash River. No property was seized by Marine Fisheries.
