

Southport Teen-Agers Sentenced In Assault, Robbery Case

Four Southport teen-agers were sentenced last week in Brunswick County District Criminal Court in connection with an assault and robbery involving a Boiling Spring Lakes resident.

According to the Brunswick County Clerk of Court's office, the defendants were Mike Davis, 18, Garland Hankins, 16, Maurice Davis, 16, and Edward Clemmons, 17, all of Southport. All four entered guilty pleas when their cases were heard Jan. 29 by Judge D. Jack Hooks Jr.

Mike Davis pleaded guilty to misdemeanor larceny and assault inflicting serious injury; Hankins, to assault inflicting serious injury; and Maurice Davis and Clemmons, to simple assault.

Hooks sentenced Mike Davis to a \$250 fine, 60 hours of community service work, two suspended two-year prison terms and three years of probation; Hankins, a \$250 fine, 60 hours of community service and a two-year suspended prison term and three years of probation; Maurice Davis and Clemmons, each a \$50 fine, 30 hours of community service, a suspended 29-day jail term and two years of probation.

Court documents indicate that charges against the four teens stemmed from an Oct. 27, 1989, incident in which Carl Alston of Boiling Spring Lakes was beaten by the defendants. Also, Mike Davis stole a Browning 12-gauge semi-automatic shotgun from Aiston; the \$300 gun belonged to Henry Alston of Boiling Spring Lakes. The four teen-agers were arrested Oct. 28, 1989, by Southport Police.
