

Shalotte Area Man Appeals Assault, Trespass Convictions

A Shalotte area man filed Superior Court appeals last week after he was convicted in Brunswick County District Criminal Court of forcing his way into a Seaside residence and pointing a gun at the occupant of the home.

Ricky Webster, approximately 26, of Brick Landing, Shalotte, was found guilty April 10 of forcible trespass and assault by pointing a gun, according to the Brunswick County Clerk of Court's office.

Prior to the defendant's appeal, Judge D. Jack Hooks Jr. sentenced Webster to a 2 1/2-year suspended prison term, two years of supervised probation, a \$500 fine and 10 days in the Brunswick County Jail. The case will be put on the calendar for Brunswick County Superior Court.

Court documents indicate that the charges against Webster stem from a March 23 incident in which Webster allegedly entered the home of Harry Harrison Cave II on Breeze-wood Road by "threatening to blow (Cave's) head off if he didn't let him in the house." Webster is accused of being armed with a small, single-barrel pistol in the incident.

Also during the April 9 through 12 term of Brunswick County District Criminal Court, Judge Hooks heard the following cases:
