

County Youths Ordered To Write Letters Of Apology For Thefts

As conditions of their suspended sentences, two youths were ordered to repay money stolen from vending machines—including \$207 to *The Brunswick Beacon*—to write letters of apology and not to associate with each other.

Bryan Benton, who pleaded guilty to five counts of breaking and/or entering, and three counts of larceny, consolidated judgment, N.C. Department of Correction two years (Criminal Youth Offender), suspended sentence three years, supervised probation three years, restitution \$325 to *USA Today* and \$207 to *Brunswick Beacon*—credit toward that if co-defendant or juveniles paid, responsible if not paid, not go on or about premises of any of plaintiffs, letter of apology to each business or owners of each vending machine, restitution \$92.50 to C.A. Timbes in South Carolina, \$37.50 restitution to Salty Surf Shop, not have any association with Chris Bowers except as attended school-on-campus activities, Brunswick County Jail 11 days to begin 8 a.m. 4-28-90 until 8 p.m. 4-29-90—credit for two days (like amount next four weekends and 5th weekend released), obey all lawful instruction of staff and rules of school, observe an 11 p.m. until 6 a.m. curfew, 48 hours of community services within 180 days with supervision of Ocean Isle Beach Police Department.

Chris Bowers, who pleaded guilty to three counts of breaking into coin/currency machine, one count of breaking and/or entering and one count of larceny, consolidated judgment, N.C. Department of Corrections two years (Criminal Youth Offender), suspended sentence three years, supervised probation three years, restitution C.A. Timbes \$92.50, restitution \$37.50 to Salty Surf Shop, reduce if co-defendant or juveniles pay, not associate with Bryan Benton unless necessary for school, letter of apology in two weeks to businesses and vendors, restitution \$225 attorney fees, 11 p.m. until 6 a.m. curfew unless accompanied by parent, served 11 days Brunswick County Jail—credit time served, 48 hours of community service within 180 days with supervision of Ocean Isle Beach Police Department, fee waived.

James Dennis Allen, DWI, Level 5, Brunswick County Jail 30 days, suspended sentence two years, \$100 and costs, surrender license, 24 hours in jail to begin Friday 12:00 p.m. 4-27-90, assessment, no blood alcohol content above .00, not violate any laws for two years.
