Florida Man Must Forfeit Van To Shallotte Police Department

A Florida man charged with felonious possession of cocaine during a roadblock in Shallotte in December must turn over his 1985 Plymouth van to the Shallotte Police Department

Mark Elliot Lauzon, 34, of Homestead, Fla., was arrested Dec. 28 after Shallotte police found approximately 17 grams of cocaine in his possession.

In a plea arrangement with the District Attorney's office last week, Lauzon pleaded guilty to a misdemeanor charge of maintaining a vehicle to keep controlled substances.

Four other charges were dismissed by Brunswick County District Court Judge D. Jack Hooks Jr. at the request of Assistant District Attorney Lee Bollinger. Those charges included possession of drug paraphernalia, carrying a concealed weapon, assault on a law enforcement officer and possession with intent to sell and deliver cocaine.

Judge Hooks gave Lauzon a twoyear suspended sentence and placed him on two years' supervised probation. He was fined \$250. In addition to forfeiting the van, several weapons and knives found in the van were also ordered to be turned over to the Shallotte Police Department.

Police Chief Rodney Gause reported that Lauzon was arrested after the vehicle he was driving was stopped at a sobriety checkpoint on Dec. 28 on U.S. 17 near Resort Plaza south of Shallotte.

Officer George Samek noticed a knife under the front seat of the vehicle when the driver opened the door. A dozen knives, three guns, an assault rifle, darts and throwing stars were found inside the vehicle, the officer's report stated.

Judge Hooks ordered that Lauzon submit to warrantless searches and not possess any controlled substances for two years. He also ordered that the defendant be assessed for substance abuse.
