

# Shalotte Couple Faces Cocaine Possession Charges

A Shalotte couple will face cocaine possession charges when their case goes to Brunswick County Superior Court.

Linda D. Hill, 35, and Raymond A. Hill, 40, were charged Dec. 27, 1990 with possession of cocaine with intent to sell and deliver and maintaining a vehicle for the sale and delivery of cocaine.

Shalotte Police Officer G.J. Samek filed charges against the suspects, who were released from the Brunswick County Jail under \$5,000 bond each.

In Brunswick County District Court last week, Judge D. Jack Hooks Jr. ruled probable cause existed for the charges and ordered that the couple stand trial in Superior Court. No date has been set.

The warrants allege that the Hills sold to undercover officers two grams of cocaine on Dec. 21, 1990.
