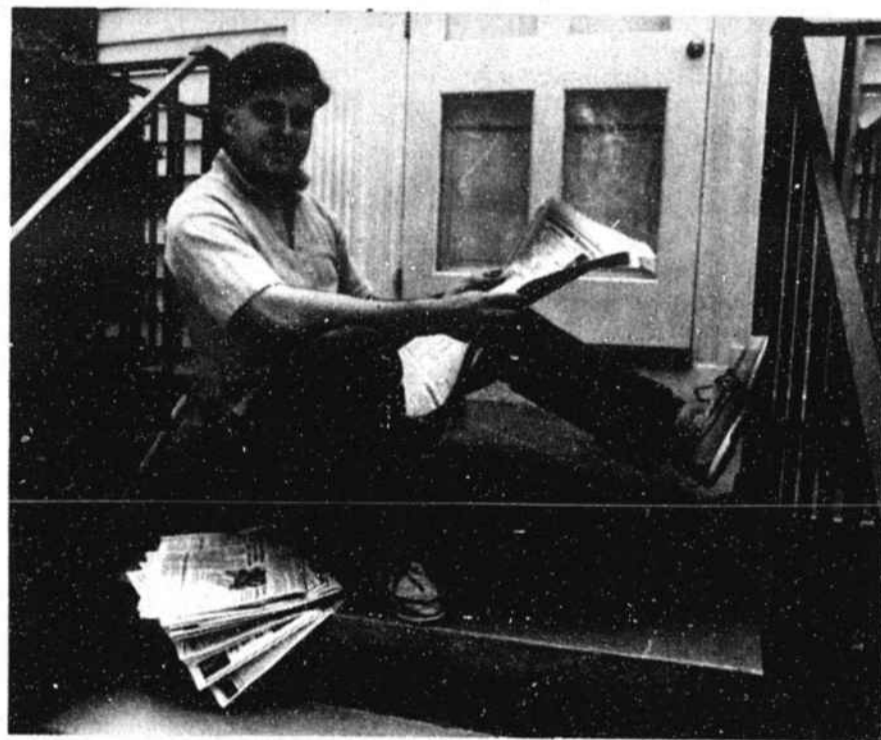


When it comes time to buy a house, seven out of ten people put a down payment on a newspaper.
