Substation BEMC's Largest, First Built By Co-op Crews

A new 25-megawatt substation at Brick Landing will be the largest operated by Brunswick Electric Membership Corp. and the first built "in house" by BEMC employees, according to Lewis Shaw, system engineer.

The utility cooperative will hold a "going-on-line" ribbon cutting ceremony for the public at 11 a.m. Friday at the substation, which is located on N.C. 179 near the Sassa-

pan Creek bridge. The new distribution system will pick up load at the east end of Ocean Isle Beach, Brick Landing and Shallotte Point and alleviate some of the load in the vicinity of Shallotte, specifically in the Brierwood Estates

Built at a cost of approximately \$750,000, it is intended to accommodate the existing and future growth in the area, Shaw said, while also it will increase reliability of service.

"It helps us in case we have an incident like yesterday (a localized power outage). We can isolate the outage and feed from another area," he said Friday. "It gives us more flexibility, more capacity and more areas to supply from.'

The next largest of BEMC's 21 other stations in Brunswick and Columbus counties is rated at 20

The new substation will have a final cost of nearly \$750,000 for labor and materials, said Shaw, comparable to what it would have cost to hire the job done by outsiders.

NRC Poses \$87,500 Fine For Plant Errors

The Nuclear Regulatory Commission proposes to fine CP&L \$87,500 for three alleged violations of NRC requirements at the utility's Brunswick nuclear plant near Southport, citing concerns for recurring personnel performance problems.

The enforcement action is based on three events that occurred in March.

In a letter informing Carolina Power & Light of the penalty, Stewart D. Ebneter, NRC regional administrator in Atlanta, said that the violations are individually of low safety impact.

However, despite CP&L's improvement efforts, he said the incidents "represent a continuing human performance problem that is of serious concern to the NRC."

He noted that such problems at the Brunswick plant have required NRC enforcement action several times during the past year, most recently in January, when a \$50,000 civil penalty was levied for failure to follow procedures during an instrument calibration test, causing an automatic shutdown.

Ebneter said the NRC recognizes that CP&L has obtained "tangible results" in some areas from improvement actions it has initiated. Also, he said the agency realizes that persistent human performance problems take time to correct.

But he said the NRC remains concerned that management at the plant has not been able to correct the root cause of recurring person-

nel performance problems. Russell B. Starkey Jr., Brunswick

Nuclear Project vice president, said company actions to support employee efforts to avoid potential human errors include counseling programs, increased training programs and increased management over-

"Although we have already seen tangible results of these efforts, such improvement programs take time to show their full effects," he said, "and our employees are committed to continued improvement."

The specific events that prompted the latest proposed fine are as fol-

■On March 15, technicians calibrating a pressure monitoring device failed to complete and properly document the procedure;

On March 26 and 27, workers performed repair work on an emergen-

cy diesel generator without having written, approved procedure for the work. This, according to the NRC, resulted in significant damage to the generator and required shut down of both units at the plant.

■On March 30, while working on another diesel generator, two employees opened the wrong circuit breaker, de-energizing some electri-

cal control devices at the plant. Both CP&L and the NRC said control room operators immediately recognized the problem and re-

stored power. CP&L has 30 days in which to either pay the civil penalty or to protest it. If a protest is denied, the company may ask for a hearing.

According to a company news release, CP&L has not decided whether it will contest the civil penalty.
