## Renter Who Left Ocean Isle Without Paying Ordered To Pay Up

A Myrtle Beach, S.C., man charged with defrauding an Ocean Isle Beach innkeeper had those charges voluntarily dismissed in Brunswick County District Court last week.

However, District Court Judge D. Jack Hooks Jr. ordered William Alan Wright Jr., 21, to pay Cooke Realty of Ocean Isle \$290 and to not go on or about property owned by the realty company.

Wright appeared in court to plead guilty to driving while impaired and injury to real property. He had also been charged by Ocean Isle Beach Police Officer T.H. Allen on May 7 with leaving a rental unit at Old Starboard town houses at Ocean Isle without paying rent.

Wright had also been charged with taking a \$35 telephone from the rental unit, according to a warrant filed at the Brunswick County Clerk of Court's office.

Charges of defrauding an innkeeper, a stop sign violation and misdemeanor larceny were voluntarily dismissed.

On the DWI and injury to real property charges, Judge Hooks sentenced Wright to 12 months in jail, suspended for two years, and placed him under two years' supervised probation. He was also give a 20day jail sentence and given credit for time served in lieu of fines or court costs.

Wright was also ordered not to operate a motor vehicle for 12 months, to undergo alcohol and drug assessment in South Carolina, undergo an evaluation at the Horry County Mental Health Center, pay \$250 in attorney fees and pay restitution to Cooke Realty.
